

Transfer Fee Adjustment - 12/6/2022

At the November board meeting, there was a motion and a second to change the transfer fee from \$275.00 to 20% of the Ranch selling price. This motion was voted on with 3 votes yes and 2 votes no with 1 abstaining. I did not vote because I believed that we had a majority vote of the voting directors since the president does not vote other than to break a tie. This vote raised the transfer fee to \$900 (20% of the current \$4500.00 selling price) effective January 1st, 2023.

It was later brought to my attention that the bylaws state that there must be a majority of the directors present not the voting directors. I have no problem admitting if I make a mistake and trying to correct it after the fact. I and the rest of the board agreed it was best to get the legal opinion on the vote.

The Ranch attorney took a little while to reply while he researched the matter. He responded recently and advised that due to the wording of our bylaws an abstention would count as a no-vote. This made the vote 3 yes and 3 no. The board had a discussion by email where I informed them that my vote was "No" as it would have been that day. This means the original motion did not pass and the transfer fee would remain at \$275.00. I then asked if there were any other motions on the transfer fee just as I would have the day of the meeting. Kenny Helms motioned to set the transfer fee at \$275.00. I stated that is what is at now unless there was a motion to change it. There was no second to his motion. I gave the rest of the board a week to respond due to some being on the road with limited email access. There were no other motions made to change the transfer fee. This means the transfer fee will not change for 2023 and will be \$275.00.

I apologize for the delay in resolving this issue as well as for misunderstanding the need for a majority of the directors present instead of a majority of the voting directors. I am human and do make mistakes and will learn from this one.

Emergency Lights & Sirens

No **flashing** Red or Blue lights and/or any type of **sirens** are allowed on any ATV/UTV or vehicle at Cloud 9 Ranch except as authorized for emergency personnel by the Fire Department or Security. Violations will result in a \$100.00 fine and/or removal from the Ranch property.
