We have many units in the compound with no # displayed or poorly displayed and unreadable # that needs to be corrected ASAP!



H. Items left in the locked compounds 2 and 3 must be moved within two (2) years. If you are not able to move the item(s) you may request a one-time six (6) month extension. The one-time request for extension must be submitted to the Ranch Manager in writing no less than ten (10) business days before your two (2) year allotted time expires. a) If you do not move your stored items within the time frame mentioned above, you will incur daily storage fees, as per current Fee Schedule, while the Ranch completes its due diligence to notify you of the sale of your property.

b) Any items that have not been removed from locked compounds 2 and 3 within six (6) months after the allotted time has expired may be removed and placed in a non-secured area pending legal action or recovery by owner. i. Daily storage fees will cease once item is moved to a non-secure area by order of Ranch Manger or designee.









As expected, our total income is down slightly, with the cost of goods sold, and expenses being up compared to the previous year. Our Net income about 16% ahead of where we had budgeted being. Our current net income is currently at 441,392.85 Some of the changes being worked toward is the switching to QuickBooks online at the first of the year. The online version is the first step to streamline bill payment and adding the ability for members to pay online. There is a lot more upgrades such as this being worked toward by our accounting team. **Audit Update given by:** Brad Clement - Board Treasurer

BDO declined doing our annual audit this year. Several companies were considered and CBIIZ has been hired to do the 2022 audit. This process has started and CBIZ has scheduled to be property November 5th through the 8th to conduct the field work of the audit. They currently are expecting to complete the audit by the end of the year.

#### C9R Accomplishments For 2023

- Cleaned out and reworked the ditch lines for better rainwater distribution.
- Trimmed the road shoulders to let water off the roads.
- Purchased New washers and dryers in our housekeeping building.
- Purchased lumber & table frames for 150 outdoor tables with the help of John Mallott, Chuck Russel and several other volunteer members that assembled them. Thank you!
- New drain system in housekeeping.
- The first ever Job Fair held at the Ranch, what a success!
- Rebuilt the Wilder handicap fishing ramp.
- Purchased an electronic LED Sign with Activities, Conservation and Ranch Riders support! Thank you!
- Added arcade games at the Big Top, Pavilion and Trading Post.
- Purchased a smoker for the Restaurant.

- Purchased six new cabins.
- All the old primary wires from the 70's have been replaced.
- Remodeled Lonesome & Fogey stage stops, for wheelchair access.
- Lonesome Pines 200-amp power disconnects were added.
- Extensive work on the Adult Pool rear deck.
- Landscaping & stacked block wall with parking area in Melody Lane at 3 of the new cabins with split rail fence.
- Replaced and added pool signage.
- Parking barriers at Wilder Springs and the handicap fish ramp.
- Updated the 9 lines look and style.
- New AC unit for the Trading Post/Restaurant.
- New raised pads in Lonesome Pines sites 103-104.
- Worked on the hill to Wilderness Way and Lonnie's Lookout with Terry Willcox.
- Installed a roof vent fan in the Trading Post.
- Concrete entrance to the pavilion, sidewalk extension to Lonesome Main, sidewalk for wheelchair accessibility at Fogey stage stop, loading and unloading pad at the handicap fishing ramp in Wilder.
- New fence at Shady Lane.
- Electrical, water and sewer engineer hired to plan out Wilder #1. Howel Oregon 3 phase line to Wilder #1 approved and has been surveyed and staked out.
- Purchased a new wood splitter for the Resource Department.
- Brian Brigman digging our clay pit and stock piling and redressing the earthen wall in Wilder #1.
- Purchased a used 4 door F-250 for the Resource Department.
- Replaced water tanks in 2 of our well houses.
- The last of the FEMA Campers have been pulled off campsites and will be in the Halloween Auction.
- Purchased 3 new door freezers for the restaurant.
- Purchased a new spray trailer and used 4-wheeler to kill gras & weeds in compounds.
- IT is being worked on and addressing our computer systems as well as our internet.
- Purchased a new Ice Cream merchandiser at the Big Top.

November 1st, we move into the off season, and we will be able to start removing dead trees as well as many other projects. In the 4 seasons that I have been Ranch Manager, this is the first time that we have been actively mowing every day through October. Normally it is spot mowing from July on. 

- Tow Straps and Winch
- Map, Compass, or GPS
- Flash Light
- Emergency Tool Kit: Vice Grips, Pliers, Allen Wrenches, Zip Tles, Duct Tape, Screwdrivers, etc.
- Extra Bolts & Nuts
- Chainsaw
- Bug Repellent
- Water or Gatorade
- High Protein Snacks
- Sunscreen

Please keep in mind if you become stranded due to machine failure that Cloud 9 Ranch and the Ranch Rider Club are not responsible to provide rescue to your machine. However, should you have a medical emergency or injury please call the Gatehouse. They will send Cloud 9 Ranch First Responders immediately as well as contact the County Ambulance and Air Medical Transport if needed.
