H. Items left in the locked compounds 2 and 3 must be moved within two (2) years. If you are not able to move the item(s) you may request a one-time six (6) month extension. The one-time request for extension must be submitted to the Ranch Manager in writing no less than ten (10) business days before your two (2) year allotted time expires. a) If you do not move your stored items within the time frame mentioned above, you will incur daily storage fees, as per current Fee Schedule, while the Ranch completes its due diligence to notify you of the sale of your property.

b) Any items that have not been removed from locked compounds 2 and 3 within six (6) months after the allotted time has expired may be removed and placed in a non-secured area pending legal action or recovery by owner. i. Daily storage fees will cease once item is moved to a non-secure area by order of Ranch Manger or designee.

"We are happy to announce that we now offer propane dispensing 24/7 again, we had a great class for our employees to get recertified and had some new certifications to help meet the needs of our members. Unfortunately, we were also informed by the State of Missouri inspector who was at the class that we must start inspecting the tanks we fill better, we were found to be not in compliance with this. We were informed that if an employee fills an out-of-date tank, they can be fined \$5000 personally as well as other fines for the Ranch. We have ordered stickers that we are required to put on each tank our employees fill. Employees will be checking for damaged tanks as well as tanks out of date. You can check your own tank to see if it is in date before bringing it up. On the collar of the tank there will be a date, if it has a date and not letter it is good for 12 years from the date on the tank. If it has a date and the letter E behind it, the tank is good for 5 years from the date. If the date has the letter S after it the tank is good for 10 years from the date on the tank. Examples : 10/20 good till October of 2032 10/20 E good till October 2025, and 10/20 S good till October 2030. A Ranger will check and let you know what the date on your tank is at the time of filling. Currently we do not have any tanks to replace damaged or out of date tanks. We will be working on getting a list together where tanks can be purchased locally."

UTV/ATV TRAIL SAFETY

Whether you are new to riding or have experience it's always a good idea to be prepared. Here are a few ideas of items to keep with you to ensure you and your crew return to camp safely.



- First Aid Kit
- Fire Extinguisher
- Tire Plug Kit or Air Compressor
- Tow Straps and Winch
- Map, Compass, or GPS
- Flash Light
- Emergency Tool Kit: Vice Grips, Pliers, Allen Wrenches, Zip Ties, Duct Tape, Screwdrivers, etc.
- Extra Bolts & Nuts
- Chainsaw
- Bug Repellent
- Water or Gatorade
- High Protein Snacks
- Sunscreen

Please keep in mind if you become stranded due to machine failure that Cloud 9 Ranch and the Ranch Rider Club are not responsible to provide rescue to your machine.
